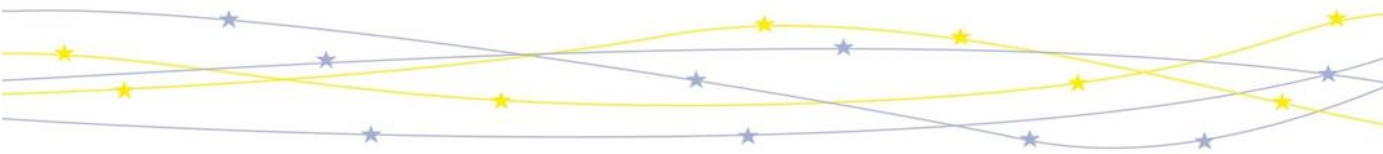

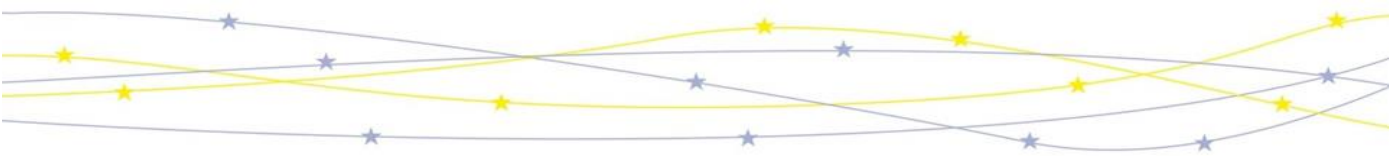
Sono stati contattati gli Stakeholder che, a cascata, hanno informato altri Enti, fino a raggiungere i potenziali destinatari.

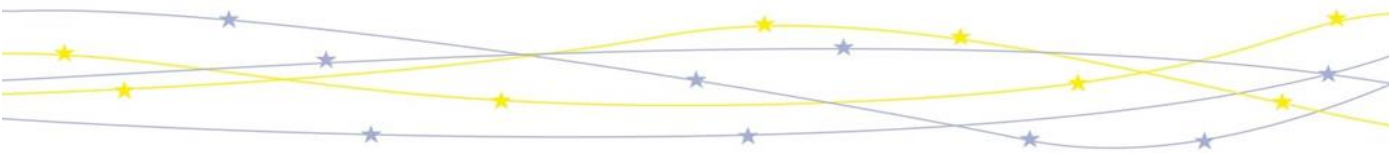

Molto efficaci si sono rivelati i canali informatici utilizzati, i siti ufficiali, i social per informare e aiutare i target dei giovani disoccupati e svantaggiati a partecipare all'avviso. Infatti, visto il target degli Avvisi di selezione e l'oggetto della comunicazione che prevedeva anche un contenuto scritto ed un link per consentire un collegamento diretto con l'Avviso di selezione e con le altre informazioni correlate, per raggiungere, nel rispetto dei principi di pari opportunità e di parità di genere, il maggior numero di destinatari, è stato più utilizzato il canale Facebook che ha consentito di raggiungere un elevato numero di soggetti. In particolare, solo con il canale facebook, nel mese di gennaio 2022, tramite questo canale sono stati raggiunti nel mese di gennaio 2022 n. 41.461 persone con 2.122 interazioni; nel mese di settembre 2022 sono stati raggiunte n. 21.383 persone con 762 interazioni e nel mese di gennaio 2023 sono state raggiunte n. 66.673 persone con 1.611 interazioni). Pertanto, il numero complessivo delle persone raggiunte ben 129.517 persone con 4.495 interazioni.

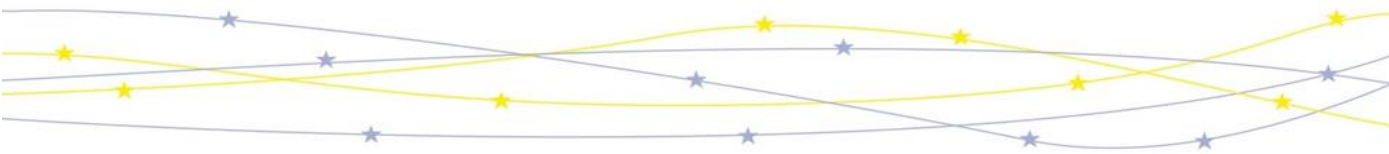

Per dare maggiore diffusione del comunicato, quest'ultimo è stato trasmesso anche attraverso canali televisivi, a livello locale Etna Channel TV ed a livello regionale su REI TV, Antenna Sicilia e Telecolor ed è stato divulgato anche sul web attraverso il sito lasiciliaweb.it. Si tratta di mezzi di comunicazione, ad alto indice di ascolto e che in Sicilia coprono tutto il territorio.

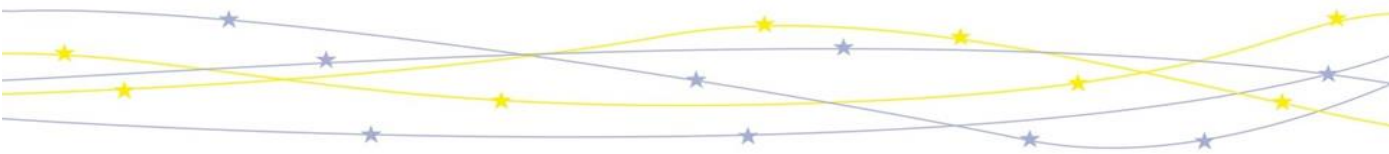
